

West Midlands Maternity Data Report - Q1 2010/11

We are pleased to present herewith the quarterly report of the WM regional maternity data collection programme, covering Q1 of 2010/11.

Overall submission rates have been gradually increasing, and have reached 90% in this last quarter:



The 5 key performance indicators are again given for PCTs as well as maternity units, and are referenced to the first year's data as a benchmark. While there has been good improvement in some of the KPIs, there is still wide variation across the region.


The results of our local data quality audits have been satisfactory overall, and are being fed back to individual units to allow them to make improvements where needed. Further such audits are ongoing and will help to highlight specific issues. Following requests from some maternity units, we have started to make available lists of each unit's own growth restricted babies which were not detected antenatally, to facilitate local audit and identification of any system or training issues.

Together with this report, we are sending the first of a series of subgroup analyses within the West Midlands maternity population, focusing on teenagers and older mothers, and their characteristics and risks during pregnancy. Further such reports are in preparation on obesity, smoking and deprivation. The next report, due mid autumn, will cover ethnicity and migrant mothers. As more cases are being collected and linked to mortality data, we will also be able to model the relative contributions which these factors have, and the potential effects of specific interventions.

- Submission rates have improved across the region and have reached 90% We are now aiming for the second year ascertainment target which was set as ≥95% from Q2.
- A number of units have main-streamed denominator data collection, with data clerks now having permanent contracts. However, several units have still not been able to embed this important function.

- A majority of units are now meeting the target of 80% and the overall WM rate has increased with each quarter. However further improvements are needed in several units, as shown in the table
- DoH are increasing this target to >90% in the current year.

- The overall rate of 'two antenatal appointments before 13 weeks' has increased from 2009.
- However, there is substantial variation between units, highlighting major differences in clinical practice.

- Continuity of carer by one community midwife continues to be a difficult target for most Trusts.
- On recommendation by the project board, this KPI will from Q2 include continuity with two midwives.

- No time trends can as yet be presented because of small numbers within the IUGR subgroup.
- However detection rates are still low, indicating that more than two-thirds of IUGR cases are missed.
- There is a wide range of detection rates which in part seem related to local practice and training.
- It is recommended that all staff including midwives, obstetricians and ultrasonographers avail themselves of the free GROW accreditation workshops provided by PI.

- The prevalence of smoking has decreased further this quarter, and the cessation rate has increased significantly
- However cessation rates vary substantially between units
- While the national target of reducing smoking during pregnancy to <15% by 2010 has been met, smoking rates vary significantly across the region, and population characteristics such as ethnicity need to be considered when comparing rates.

- Preliminary findings suggest an increase in breastfeeding initiation rates of 1.8% since the last financial year.
- Rates vary according to population characteristics and these should be considered when comparing unit figures.

Submission rates are calculated as the number of cases submitted from each quarter, as a proportion of all births in that quarter (estimated on the basis of last available data from 2008/9, if actual figures not available). Data received is dependant upon the completeness of notes recorded by care providers, and sustained capacity of data clerks ensured by Units and respective PCTs.

The submission rate target for Q2 onwards will increase to 95% to improve data quality further.

The PI have commenced a pilot of Digital Pens for community midwives to facilitate ascertainment of real-time data (Heartlands, Walsall, Warwick, North Staffs and George Eliot).

Data quality

Gestation at booking is validated by dating scans. However, standards of record keeping, and in particular the record of completion of medical and social risk assessment, vary in quality, as demonstrated by our recent regional audit.

Performance & Progress

The results show that most units and PCTs have achieved the 80% project target.

Further improvement is required as the DH's aim is to increase the national target to 90% by end 2010/11.

Units offering a home booking service tend to have a higher attainment rate and a more comprehensive assessment of social needs.

Two antenatal contacts are recommended to allow women time to consider offers of blood tests and screening before these are taken. Many units are currently unable to fulfil this target. Units that do better usually combine the dating scan with a midwifery contact

Ascertainment of this data item is sometimes difficult because of illegible signatures or care providers' names not being recorded.

Target is particularly challenging due to limited capacity and working practices. However results show large variation and suggest that better continuity of carer is achievable.

IfH Project Board has reviewed this indicator upon completion of 12 months of data collection.

An alternative option to collect continuity with a team of two midwives has been agreed and will commence data collection in Sept 2010.

Dispersed service models of community maternity care across the region impact upon continuity. Commissioners and providers are advised to consider a locality based service to increase economies of scale, reduce travel and permit greater cohesion of maternity care

Data quality

Because this indicator describes a subgroup (antenatal detection) of a subgroup (cases with FGR), we present combined data from Q1 2009 to Q1 2010 inclusive. 'Antenatal detection' is based on close scrutiny of case notes and growth charts. Case note audit of FGR cases has shown that ascertainment by data clerks is reliable. However, clinicians' recording of detection of SGA / FGR / IUGR is often poor; therefore an EFW <10th centile was used as an additional indicator.

Performance & Progress

The rates of babies with fetal growth restriction ranges from 12.6% to 17.9% in the West Midlands. FGR varies with factors such as deprivation and smoking. The wide range of detection rates suggests room for improvement. The highest detection rates tend to be observed in the units which had the most intensive training. The unit with the lowest detection rate (10.6%) has had no training and is the only one in the West Midlands not using customised charts for their population. The results also show that once a woman is referred for scan on the basis of fundal height measurement, the detection rate is significantly higher.

Additional comments

Confidential enquiries into perinatal deaths have highlighted importance of antenatal detection of FGR. Free accredited GROW training is provided by PI in fortnightly workshops. Starting from October, provider units will be forwarded a list of their 'missed IUGR cases to assist with their local audits of fetal growth surveillance.

Comments

This analysis looks at the cases where information about smoking is available at the beginning and end of pregnancy.

Cessation rates for Q4 & Q1 are 28%, which represents a significant increase from the first two quarters last year (OR 1.1.4, Cl 1.0-1.3)

However there is wide variation between units which needs to be looked at. Further work is also being undertaken to improve data quality.

NB Referral and cessation rates appear higher in units with an OPT-OUT policy is in operation for referral to smoking cessation services Further analyses will be reported on later this year on the effects of smoking on perinatal outcome in the West Midlands.

Data quality

Collection of this indicator is difficult because:

- 1. Reliance on the labour record is insufficient as breastfeeding may not have commenced prior to discharge;
 2. The postnatal notes are taken home by the mother and there is often a delay before they are available to the data clerks; or
 3. The time of commencement is not recorded. Improved documentation around time of first breastfeed is vitally important.

Performance & Progress

There is wide variation in breastfeeding initiation rates around the region. This needs to be considered with consideration of differences in population characteristics Preliminary figures show a small increase in rates cross the patch. However, further work is needed on improving record keeping.
