## Agenda Items

### 1. Introduction

- Welcome and individual introductions, group includes representation from clinical midwives, supervisors of midwives and midwifery managers

## **Quorum**

- At least 9 units must be represented at each meeting.

## **Meetings**

## **5. Presentation by Pat McGeown – NICE Antenatal Care Guideline**

- Highlighted what aspects of the guideline are already undertaken in the region.
- Highlighted discussion points for group to respond to.

## **6. Local Implementation and Response**

- **Reduced antenatal visits**, It was agreed one care pathway does not fit all, and antenatal care should be individualised to the woman regardless of parity, with the emphasis being on the quality of the contact given. The average number of visits was thought to be about 10.
- **Routine MSU's for asymptomatic bacteriuria**. Treatment reduces the risk of preterm birth. Varied implementation across the region. Some units were offering an MSU to all women, some to only their 'high risk' women; others had yet to implement any level of screening.
- **Urinalysis is a poor screening test for GDM**. Implementation of this recommendation has been hampered by the difficulty in attaining single test reagent strips. Others are awaiting ongoing research findings before changing practice.
- **Abdominal Palpation for fetal Presentation**. The Forum noted that all units represented still assess fetal presentation prior to 36 weeks to ensure the maintenance and development of clinical midwifery skills. As well as promoting maternal awareness of her developing baby.
- **Auscultation of fetal heart**. All present acknowledged the lack of predictive value of auscultation however the units represented continue to auscultate and document findings as it promotes the mother-baby bond, especially when using a sonicaid.

## **7. Any other Business**

- Group asked to discuss in own units and bring suggestions for future topics to subsequent meetings
- As there is no budget for the Forum it was agreed that attendees should bring own lunch. Tea & Coffee will be provided.
